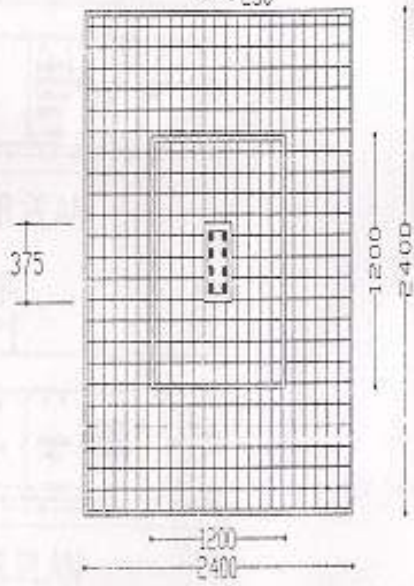

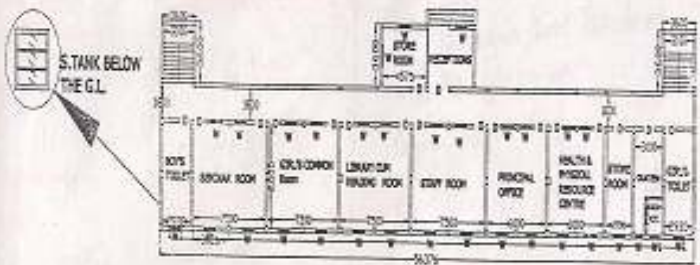
ROOF PLAN

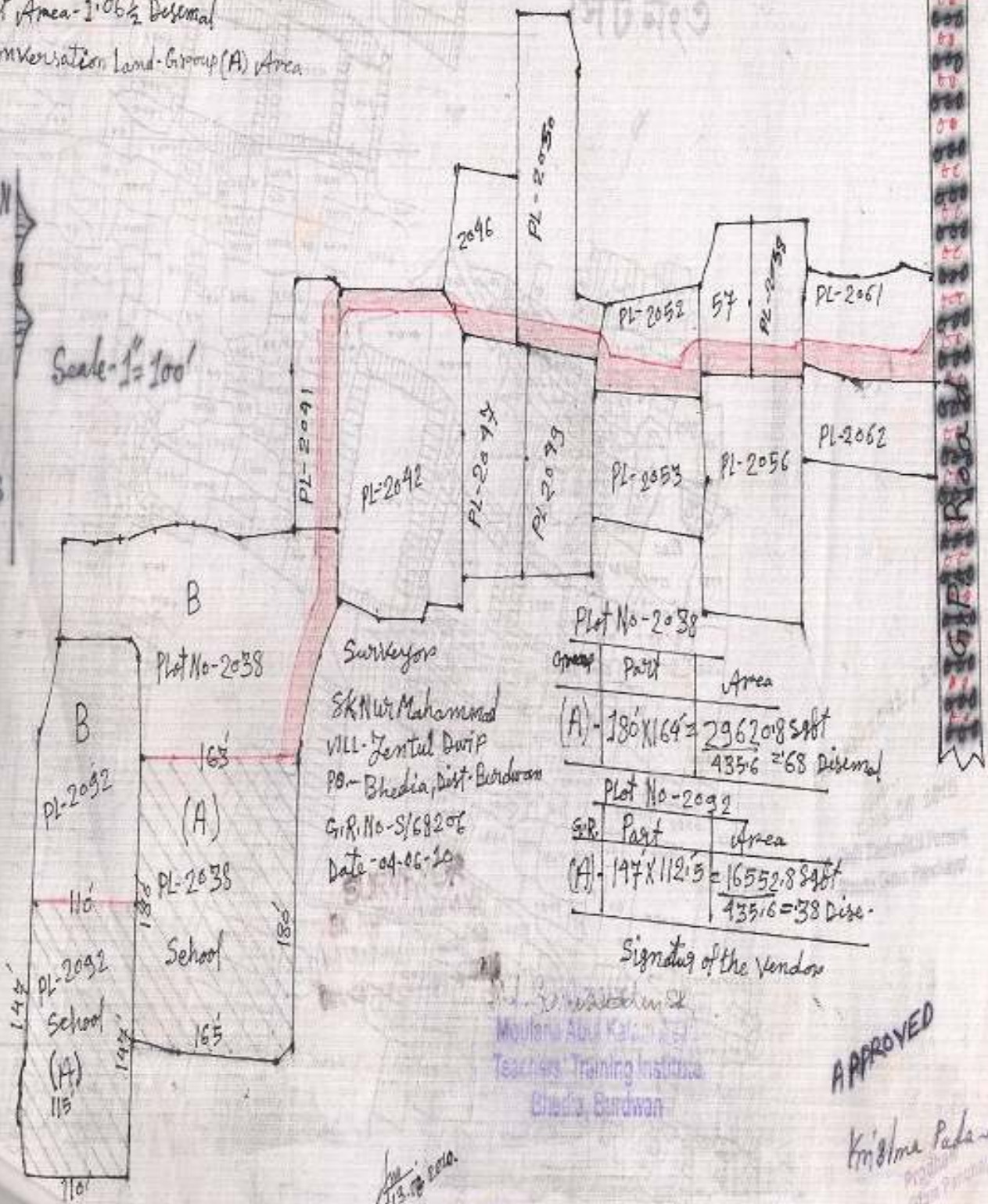
